Operational Status Report: David Palomares, Executive Director, reported on CMF projects and experiences December 14th, 2021 through January 10th, 2022, which included conducting the second class for Clifton Art Academy on iPhone Moviemaking, the CMF Staff Holiday Party, the studio Christmas closure, the reopening of the studio, the addition of the RING doorbell to the studio, the exposure of OMNICRON to the studio staff which lead to the depletion of our CoVid rapid test supply, and the temporary 2 week closure of the studio to adjust to the new normal of life with Covid. Also reported server updates with Giggle Fiber, Spectrum, and BTV, reported on upcoming Monrovia State of the City in-person event and streaming, and concluded with happy belated birthday wishes to Marlene Gibb and Robert Grimes. Requested Board members state their birthdays to put on the calendar. New protocol is being discussed on how to move forward in running the studio, events, and programs with the Omicron virus still prevalent. Congratulations to Chris Loos for the 6th show of

**Rena Delgado:** Congratulations to **Barbara Gholar** for her output of shows, as well as all our producers/directors, for continuing to produce content through this challenging pandemic.

Also discussed **D&O** insurance policy and the cost analysis. We may not have time to discuss mediation tonight. Board Members have received the one and only proposed quote we could get that shows the increase of insurance costs, the retention fees, and other related costs, and how they effect the agreements with the cities we deal with. Also stated how the current, and future legal fees are, and can be, effected by these policies. Nationwide Insurance has cancelled us, but they will still pay for our lawyers to defend us in the two pending lawsuits:

- 1) Kelty vs CMF
- 2) Kelty vs Delgado with CMF derivatively.

Results from Nancy Bond Insurance Brokerage lead to only one policy being offered to CMF at this time. The question proposed to the Board is: Do we decide as a Board to pay both the \$10,150 policy, a deductible of \$100,000, and reduce coverage, or do we designate \$100,000 of current funds in the bank to start a CMF legal fund? This is NOT the main policy we carry, nor a requirement of our city agreement, this is only 1 policy of 5 that we pay for. The risk is we will most likely be impacted by the lawsuits we are currently facing for at least 5 - 6 more years.

MOTION: To approve paying \$2,600 for 3 months insurance coverage while the Board researches options on other insurance plans. MOTION: Rena Delgado SECONDED: Dirk Beechem MOTION CARRIES

**RENA DELGADO:** States she is unable to speak on the Kelty vs Delgado / Media of the Foothills lawsuits, but she does want to state the lawyers are trying to resolve both cases concurrently. With that in mind, the discussion is started on a project to inform the public of these lawsuits.

MOTION: To approve establishing a committee to educate and inform the public about CMF's circumstances regarding the current lawsuits against CMF. MOTIONED: Doug McComb / SECONDED: Dirk Beechem MOTION CARRIES

**Rena Delgado, Doug McComb, Dirk Beechem** all agree to be a part of the Public Statement Committee on the Kelty vs CMF lawsuit. **David Palomares** and our attorney can participate, but they will not have a vote.

**Rena Delgado:** Public statement should be crafted by combined participants devised of approved Board committee, **a** Monrovian Crisis Management Consultant, and our attorney, so we do not erroneously mention any information that can hurt our case.
