## D. Operational Status Report:

**David Palomares, Executive Director,** Happy Holidays to all, **reported on** programs experienced October 26th, 2021 through December 13th, 2021, which includes shooting and editing of 13 shows. Studio was closed November 22nd to the 26th, 2021, for Thanksgiving. **Mr. Palomares** continued report with server issues, and an update on equipment replacements and service call needs, as well as working on connection with City Hall digital signage, and live and aerial shots. On December 10th we had an inspection with Giggle Fiber President, Mr. Herbert Villalobos,

regarding broadcasting issues previous to adding new server. Mr. Villalobos suggested we switch everything over to digital, and offered an equipment upgrade at Giggle Fiber's expense, so long as we split cost on digital broadcast equipment, which will allow us to broadcast in HD. It is infrastructure, so we will be reaching out to the City to help with the expenses. Any Giggle Fiber customer in Monrovia and Arcadia can now see our shows, which may broaden our viewership. **Mr. Palomares** also gave a 2021 Overview: We shot and produced 186 productions and City meetings in 2021, which is much more than any previous year.

Studio will be closed December 22, 2021through January 3rd, 2022 for the Christmas Holiday.

**David Palomares concluded his report** thanking staff and everyone involved with KGEM, and the productions of 2021. Rena Delgado concurred.

**David Palomares** also reported on an emergency purchase made for a Maxcom Broadcast Transmitter/Receiver, mentioned above, which was needed to be able to continue broadcasts. Our outdated one, was no longer performing correctly. Spectrum has the same issue as Giggle Fiber, so it needed to be updated or changed out as well. and it too, is part of the infrastructure, as mentioned above. Without this equipment upgrade, we cannot broadcast our 3 channels to Spectrum. Cost was \$2,652.26, which includes a 20% discount, but due to the urgency of replacement, it needed to be replaced before the next board meeting, so the item was preordered.

A discount applies if we send 4 people.

**Robert Grimes**: Reported on Monrovia Film Festival proposal, the opportunity and benefit for both CMF and the Monrovia Community. **Rena Delgado** suggests the Board calendars a day for a Study Session, and that we review and update our by-laws, so that we may participate within the rules of the by-laws.

Board members, **Doug McComb**, **Dirk Beechman**, **and Barbara Gholar**, inject their own comments on this opportunity. **Robert Grime**'s nonprofit will take on producing this project first, so CMF can have the time needed to prepare to take this project over the following year. The **CMF Board** encouraged **Mr. Grimes** to take the next step in continuing to pursue this opportunity, as the **CMF Board** researches feasibility of supporting and developing the production of a Monrovia Film Festival partnership. Research will be conducted on CMF by-laws, and modifications needed, to make this project an option worth considering. **Rena Delgado**: Reported on ACM Weekly News Update - Call to action on Protecting Community Television Rights bill: Recommended Board members call Senators and representatives to request they become Co-Sponsors of this bill.
