Receiving Financial Discussion: Payroll Breakdown:

DM asked: "What are the payroll wages and can they be more specific with a breakdown in regards to the CMF staff?" For example: Include information of payroll raises for all employees. How many CMF full-time/part-time staff? What are their hours? How much do they receive monthly? **DM** suggested it be itemized. **DB** wants to know how many hours each employee has worked. **DP** stated he receives a salary, and he'll research regarding breakdown for the rest of the staff. **DP** stated he will check with accountant regarding modifying information to make it easier to understand. **DM** followed up wanting to know what we do know. **DB** stated: "We don't think these numbers are wrong, we'd just like to know what each one makes, and how many hours they work? **RD** stated, "It sounds like a motion should be made for itemized detailing on that information, but it doesn't sound like you have a problem with adapting the motion to approve, receive and file, of the November/December financials. So let's call for a vote - no one is objecting to accuracy of the report, you just want more detail."

CLOSED SESSION: Dennis Kasper, Atty - Dennis Kasper introduced himself. He stated the bulk of his clients are charities. He has been in this line of work for 30+ years. He has clients nationwide, but he resides locally. He will discuss specific steps that need to be taken regarding election, by-laws, and meeting decorum and methodology. **DM** informed the Board that Kasper's firm has 1400 attorneys, located in 52 cities, 29 states, and that Kasper has been licensed in California for the past 46 years. **RD** thanked **DM** for his research.

David Palomares, Executive Director's Report

DP reported November 21st, **CL** is doing a show entitled INSIDE MONROVIA, which will become part of the regular line up. November 23rd through November 27, 2020, the studio was closed for Thanksgiving. 11/24 - Baldwin Park conducted an antibody testing shoot that was edited and aired by the 27th. Over 1000 people attended, November 24th, we premiered the Foothill Unity Center's recent Dental Clinic with USC Dental school. CMF is doing a video for retiring Duarte City Council Member John Fasana. November 30th, Clifton Zoom class was held entitled "Video & Editing on your Smart Phone." December 7-12th, students shared their work. The class was limited to a number of students, the next class will be unlimited. DB asked if any of those films will be shown on KGEM or KMAC? DP answered, No, the films weren't long enough to put on as a program. DB stated that because the next class would be unlimited, maybe now kids, from different schools, will participate. On December 18t The Delgado Brothers aired a LIVE in studio Christmas show. DP filmed and Chris switched, while still using proper social distancing procedures. **DM** asked if they wore masks? **DP** answered, yes, and stated that the whole band kept their mask on throughout the show. DB asked was there another Monrovia band? DP answered, Outrageous 8. DB stated that hopefully, after COVID, they'll open Jazz Session again. DP mentioned that we were fortunate to capture the Delgado Brothers. They won't be playing again until everyone is vaccinated. December 21 a crew video taped the Baldwin Park Covid testing and press conference, December 21 - January 1st, 2021. Studio was closed for renovation and updates. They have also been working with the green screen and readying equipment. State of the city is in process, it will done virtually. We have also been using the drone to fly through Monrovia for some of the footage. DM asked if it had great focus? DP answered 2.7k higher than Hi-Def equivalent to one of our drones but smaller. DP We are also discussing historical videos, virtual tours of homes, and sharing some of our footage to help the historical museum. There have been a lot of cancellations due to increase of CoVid, but we have had plenty of other projects to keep us busy. We have had a few close encounters with CoVid 19, but the staff is getting tested often, and the studio has purchased a thermometer so temperatures are taken daily. The studio is in the Phase 1C group for receiving CoVid vaccine shot, so we may be able to get inoculations by March through May. Our new promo video about the studio and reopening is in the works. DP Thanked the staff, they have been very good at being available, following CoVid protocols, and keeping us all safe. Oper ating during a Pandemic is like the Netflix's current hit "The Queen's Gambit". We have to map out and plan all our moves, while taking all the Covid-19 precautions in to consideration. Everyone is hopeful that the light at the end of the tunnel gets bigger and bigger.
