Grown a lot in the video production quality. Very focused on community involvement with our Board on the train as well as filming it.

Jeffrey Ramos is our new social media director. Goal is to grow our media presence.

Partnership with Julie Bank to develop a partnership with Clifton Middle School.

New equipment and refurbishments. Twenty two items needed to be fixed or renewed. Expanded the director's booth. Decluttered, organized and repaired. Painted the lobby and new metal shelves. More earthquake ready and less trip hazards. Many positive responses.

Goal: to make this a successful year for our studio.

Vote to change the phrase civic pride to civic engagement in our mission statement. Rena brought up the idea of a labor attorney to make sure that we are in compliance with labor laws. Retainer is \$1,000 with a possible limit of \$4,000 before we continue. Board members did get a letter with more details. Doug Combs made the motion to engage the labor attorney. Meredith Luiten seconded. Motion carried.

- Board Member participation action item: write reviews, like and post online in social media platforms and non-profit websites, write and/or call state representatives in support of Protecting Community Television Act; help update CMF Policies and Procedure.
- 6. Action: Discuss and confirm participation. Barbara Gholar mentioned the idea of a "Meet and Greet" session where the board members and producers could each invite one or two people to visit the studio and to hold an event to dicuss the benefits of membership. Personal invitations much more important than email blasts.
- 7. Rena asked if Board Members could write or call State Representatives regarding the Protecting Community Television Act.
- 8. Policy and Procedures Manual needs to be updated. Rena asked for volunteers to help with this.
- 9. Jeffrey Ramos had a few minutes to discuss Social Media. He asked us to "like" posts of KGEM on social media and to comment if possible. Jeffery is working on creating a personality of KGEM. Will be using data to drive engagement. Are people interacting with your material? 5.1 engagement rate. 5.6 is our goal.
